Have agreed the following:

Section 1 / Subject

- 1.1 Breeder sells to Buyer the **Thai (traditional Siamese) cat** with <colour> point colour, named <name> for breeding/ not for breeding (delete as appropriate), including:
 - Pedigree / Certificate of descent with number <number> (see annex A)
 - European Vaccination passport (annex C)
 - Ownership documents (annex D)
 - Identification chip with number <number> (annex E)
- 1.2 The General Regulations as mentioned in annex B apply to this Contract.

Section 2 / Realization and execution of the Buy

- 2.1 The Buy is realized if:
 - a) Buyer has paid his/her financial duty's towards Breeder (see section 3)
 - b) Both parties have signed this Agreement

Section 3 / Compensation, payment, delivery

- 3.1 Breeder is entitled to a compensation of € <amount> (in words: <amount> euro's). This compensation includes the costs of:
 - Pedigree
 - European Vaccination passport
 - Vaccination of the cat (feline panleukopenia (distemper), feline viral rhinotracheitis and feline calicivirus) and the first rabies vaccination), as prescribed by the veterinarian of Breeder
 - Worming of the cat on prescription of the veterinarian of Breeder
 - Identification chip
- 3.2 The compensation named in section 3.1 is paid in cash by Buyer before or at the latest on the moment of delivery of the cat.
- 3.3 Breeder has the right to renounce the purchase when Buyer has not or not fully payed the compensation and Buyer is in neglect.

Section 4 / Death

- 4.1 The buy is annulled in case the cat dies in the period before delivery. Any compensation, already paid by Buyer to Breeder on behalf of the Buy will be restituted by Breeder.
- 4.2 Death of the cat before delivery doesn't give Buyer any right to further compensation by Breeder nor can Buyer assert any right to an other kitten of Breeder.

4.3 Buyer can claim a compensation in case the cat dies within 1 year after delivery, providing Buyer can proof by veterinarian drawn up and signed report that death of the cat has been caused by an illness, ailment or defect that already existed at the time of buying. In such a case Breeder and Buyer will consult about the type and amount of compensation. This compensation will not exceed the purchase price (see section 3.1) in any case. Breeder is not responsible for any expenses Buyer had to make for treatment of the cat or in behalf of the report by a veterinarian/pathologist.

Section 5/ Observable and Hidden Ailment(s) of the cat

- 5.1 At delivery of the cat Buyer makes certain that the cat has no exterior observable ailments and/or defects and no other ailments and/or defects then already known to Buyer. In case of already known ailment(s) this will be named and mentioned by the veterinarian of Breeder in the vaccination passport (see section 3.1). Buyer declares to know and agrees with the ailment(s) in case of such mentioned in the vaccination passport by signing this agreement.
- 5.2 Breeder is obliged to inform Buyer about the known ailment(s) and/or defect(s) before establishing the purchase. Buyer has the right to renounce the buy based on this information, unless he/she declares to agree with already named ailment(s) according to section 5.1.
- 5.3 Buyer is entitled to refrain from the sale after delivery of the cat in case of diagnosis of an ailment and/or defect (other than mentioned in the vaccination passport) that already existed or can be reduced to an ailment and/or defect at the moment of signing the Contract, provided Buyer immediately, or at least within 14 days after signing this Contract, informs Breeder about the ailment and/or defect with a written and signed statement of a veterinarian. If so, Breeder will take back the cat and refund the whole compensation.
- 5.4 Refunding the compensation will be expired in case of a diagnosed ailment and/or defect, such as named under section 5.3, if Buyer wants to keep the cat.

Section 6 / Property

- 6.1 The cat remains property of Breeder, until all obligations are met.

Section 7 / Final article

- 7.1 This agreement is subject to Dutch law.
- 7.2 In case a disagreement between parties can't be solved, a competent court at [<residence>](#) is authorized to decide about this Contract relating to the disagreement.
- 7.3 All other agreements and Contracts concerning the cat between Breeder and Buyer expire after signing this Contract.

Annex B

GENERAL REGULATIONS

- 1 Buyer declares not to be acting as an intermediary for others.
- 2 Buyer declares the cat from corresponding Contract is sold to him/herself. In case Buyer wishes to renounce or decides to sell the cat, Buyer will notify Breeder ASAP of this intention. If so Breeder has the right to take back or to buy the cat. In case of repurchase the compensation will be arranged in consultation, but the compensation will not exceed the compensation as mentioned in the Contract.
- 3 Breeder declares the cat to be in good health on the day of delivery, fully vaccinated against cat flu and cat disease and wormed.
- 4 Buyer is obliged to take good care of the cat, to vaccinate and worm the cat periodically in accordance to the veterinary prescriptions, to give the cat healthy food and a clean environment with enough freedom of movement (no cage). The cat will be returned immediately to Breeder in case Breeder or a third party establishes maltreatment or neglect of the cat, without any compensation at all.
- 5 Under no condition the cat will be de-clawed.
- 6 Weighty advice to the cat not free to run outdoors, unless within a secure enclosure in such a way that the cat cannot reasonably escape to the public space.
- 7 In the event Buyer can't keep the cat due to circumstances, Buyer needs to seek a good substitute home and inform Breeder ASAP of this intention. Name and address of the new owner will be passed to Breeder. The cat will never be placed in an animal shelter. In case Buyer can't find a good address for replacement, the cat will be delivered back to Breeder. Transportation costs will be at the expense of Buyer.
- 8 If Buyer moves, he/she will notify Breeder within a month.
- 9 A queen won't mate before she is 12 (twelve) months old, unless there are medical reasons to justify mating at an earlier age. A queen will under no circumstances have more than three litters in 24 months.
- 10 The cat will not be let out, lend, or sold to another Breeder or private individual without explicit written agreement of Breeder.
- 11 Breeder will be notified when a cat is terrible ill and/or after death of the cat before the cat is 10 years old. If possible the breeder shall advice to do an post mortem autopsy. If death happens within the year after deportation the buyer can claim compensation proposal.
- 12 The buyer gives permission to contact details (name, address, telephone number, email address) to register with the Working Group Traditional Siamese Netherlands (WTSN). **Yes or No.** This data may be used for the purposes of health studies over several years
